AWARD CRITERIA

- Nominated businesses must be owned 51% or more by a woman or member of the minority community, and the daily business operations managed by the owner.
- These individuals or businesses should demonstrate excellence and ethnic/gender diversity.
- Nominees may be self-nominated or nominated by a San Angelo resident.

AWARD CATEGORIES

1. **Business Success Award** – A minority or women-owned business exemplifying quality service, growth, integrity, and professionalism in dealings with the public or employees.
2. **Legacy Award** – A minority-owned, multi-generational business in continuous operation for ten years or more that exemplifies service to and investment in the minority community.
3. **Communicator Award** – Individual or organization that provides information about issues and events important or relevant to minority communities.
4. **Community Impact Award** – Individual or business that consistently promotes diversity and inclusion.
